At a Meeting of the Freebolders and other Inhabitants of the Town of Bolton, duly warned, and legally affembled, in Fancuil-Hall, on Wednefday the 28th of October, 1772; and from thence continued by Adjournments to Monday the 2d of November following.

It was moved,

THAT a Committee of Correspondence be appointed, to confist of Twenty-one Perfons, "to state the Rights of the Colonists, and of this Province in particular, as Men, as Christians, and as Subjects, ; to Communicate and Publish the fame to the feveral Towns in this Province, and to the World, as the Sense of this Town, with the Infringements and Violations thereof that have been, or from Time to Time may be made; also requesting of cach Town a free Communication of their Sentiments on this Subject."

At a Meeting of the Freeholders and other Inhabitants of the Town of BOSTON, duly warned and affembled in Fancuil-Hall according to Law, on Friday the 20th of November, 1772; then and there to receive and act upon the Report of a Committee appointed at a former Meeting on the 2d of the fame Month, and fuch other Things as might properly come under the Confideration of the Town.

The Honorable JOHN HANCOCK, Efq;

Being unanimously chosen Moderator,

The Chairman of faid Committee acquainted him that he was ready to make Report, and read the fame as follows.

THE Committee appointed by the Town the fecond Inftant "to state the Rights of the Colonists and of this Province in particular, as Men, as Christians, and as Subjects; to communicate and publish the fame B to

to the feveral Towns in this Province and to the World, as the Senfe of this Town, with the Infringements and Violations thereof that have been, or from Time to Time may be made. Also requesting of each Town a free Communication of their Sentiments on this Subject,"-----beg Leave to report.

Firft, A State of the Rights of the Colonists and of this Province in particular.

Secondly, A Lift of the Infringements and Violations of those Rights.

Thirdly, A Letter of Correspondence with the other Towns.

I. Natural Rights of the Colonifts as Men.

Among the natural Rights of the Colonists are these: First, a Right to Life; secondly, to Liberty; thirdly, to Property; together with the Right to support and defend them in the best Manner they can. These are evidentBranches of, rather than Deductions from theDuty of Self-Preservation, commonly called the first Law of Nature.

All Men have a Right to remain in a State of Nature as long as they pleafe : And in Cafe of intollerable Oppression, civil or religious, to leave the Society they belong to, and enter into another.

When

When Men enter into Society, it is by voluntary Confent; and they have a Right to

demand and infift upon the Performance of fuch Conditions and previous Limitations as form an equitable original Compact.

Every natural Right, not expressly given up, or from the Nature of a focial Compact necefarily ceded, remains.

All positive and civil Laws, should conform as far as possible, to the Law of naturalReason and Equity.

As neither Reafon requires, nor Religion permits the contrary, every Man living in or out of a State of civil Society, has a Right peaceably and quietly to worfhip GoD, according to the Dictates of his Conficience.

" Just and true Liberty, equal and impartial Liberty" in Matters spiritual and temporal, is a Thing that all Men are clearly entitled to, by the eternal and immutable Laws of GOD and Nature, as well as by the Law of Nations, and all well grounded municipal Laws, which must have their Foundation in the former.

In Regard to Religion, mutual Toleration in the different Professions thereof, is what all good and candid Minds in all Ages have ever practiced; and both by Precept and Example B 2 inculcated

inculcated on Mankind : And it is now generally agreed among Christians, that this Spirit of Toleration, in the fullest Extent confistent. with the Being of Civil Society, " is the chief characteristical Mark of the true Church."* Infomuch that Mr. Lock has afferted, and proved beyond the Poffibility of Contradiction on any folid Ground, that fuch Toleration ought to be extended to all whose Doctrines are not subverfive of Society. The only Sects which he thinks ought to be, and which by all wifeLaws are excluded from fuch Toleration, are those who teach Doctrines subversive of the civilGovernment under which they live. The Roman Catholicks or Papifts are excluded, by Reafon of fuch Doctrines as thefe. " that Princes excommunicated may be deposed, and those they call Hereticks may be destroyed without Mercy; befides their recognizing the Pope in fo absolute aManner, in Subversion of Government, by introducing as far as possible into the States, under whofe Protection they enjoy Life, Liberty and Property, that Solecism in Politicks, Imperium in Imperio⁺, leading directly to the worft Anarchy and Confusion, civil Discord, War and Bloodshed.

The natural Liberty of Man, by entering into Society, is abridg'd or restrain'd so far only

only as is necessary for the great End of Society, the best Good of the Whole.

In the State of Nature, every Man is, under GOD, Judge, and fole Judge, of his own Rights, and of the Injuries done him : By entering into Society, he agrees to an Arbiter or indifferent Judge between him and his Neighbours; but he no more renounces his original Right, than by taking a Caufe out of the ordinary Course of Law, and leaving the Decision to Referees or indifferent Arbitrators. In the last Cafe he must pay the Referces for Time and Trouble ; he fhould also be willing to pay his just Quota for the Support of Government, the Law and the Constitution ; the End of which is to furnish indifferent and impartial Judges in all Cafes that may happen, whether civil, ccclefiastical, marine or military.

"The natural Liberty of Man is to be free from any fuperior Power on Earth, and not to be under the Will or legislative Authority of Man; but only to have the Law of Nature for his Rule."*

In the State of Nature, Men may, as the Patriarchs did, employ hired Servants for the Defence of their Lives, Libertics and Property; and they fhould pay them reafonable Wages. Government

Locke on Government,

Government was inflituted for the Purpoles of common Defence; and those who hold the Reins of Government have an equitable natural Right to an honorable Support from the fame Principle " that the Labourer is worthy of his Hire": But then the fame Community which they ferve, ought to be the Affellors of their Pay : Governors have no Right to feek and take what they please ; by this, instead of being content with the Station affigned them, that of honorable Servants of the Society, they would foon become absolute Masters, Despois and Tyrants. Hence as a private Man has a Right to fay, what Wages he will give in his private Affairs, so has a Community to determine what they will give and grant of their Substance, for the Administration of publick Affairs. And in both Cafes, more are ready generally to offer their Service at the propoled and stipulated Price, than are able and willing to perform their Duty.

In fhort, it is the greatest Absurdity to suppose it in the Power of one or any Number of Men, at the entering into Society, to renounce their effential natural Rights, or the Means of preferving those Rights ; when the grandEnd of civil Government from the very Nature of its Institution, is for the Support, Protection and Defence of those very Rights : The principal of which as is before observed, are Life, Liberty and and *Property*. If Men through Fear, Fraud or Mistake, should in *Terms* renounce or give up any effential natural Right, the eternal Law of Reason and the grand End of Society, would absolutely vacate such Renunciation; the Right to Freedom being the Gist of GOD ALMIGH-TY, it is not in the Power of Man to alienate this Gist, and voluntarily become a Slave.

H. The Rights of the Colonifts as Christians.

These may be best understood by reading and carefully studying the Institutes of the great Lawgiver and Head of the Christian Church: which are to be found clearly written and promulgated in the New-Testament.

By the Act of the British Parliament commonly called the Toleration Act, every Subject in England, exceptPapists, &c. was reftored to, and re-established in, his natural Right to worship GOD according to the Dictates of his own Conficience. And by the Charter of this Province, it is granted, ordain'd and establish'd (that is declared as an original Right) that there shall be Liberty of Conficience allow'd in the Worship of GOD, to all Christians except Papists, inhabiting, or which shall inhabit or be resident within faid Province or Territory.* Magna Charta itself is in Substance but a contrain'd

ftrain'd Declaration, or Proclamation and Promulgation, in the Name of King, Lords and Commons, of the Senfe the latter had, of their original, inherent, indefeazible naturalRights ;† as alfo those of free Citizens equally perdurable with the other. That great Author, that great Jurist, and even that Court Writer Mr. Justice Blackstone holds, that this Recognition was justly obtain'd of King John Sword in Hand : And peradventure it must be one Day Sword in Hand again refeued and preferv'd from total Destruction and Oblivion.

III. The Rights of the Colonifts as Subjects.

A Commonwealth or State is aBody politick or civil Society of Men, united together to promote their mutual Safety, and Prosperity, by Means of their Union.[‡]

The absolute Rights of Englishmen, and all Freemen in or out of civil Society, are principally, personal Security, personal Liberty and private Property.

All Perfons born in the British American Colonics, are, by the Laws of GOD and Nature, and by the common Law of England, exclusive of all Charters from the Crown, well entitled, and

and by Acts of the British Parliament are declared to be entitled, to all the natural, effential, inherent and infeperable Rights, Liberties and Privileges of Subjects born in Great-Britain, or within the Realm. Among those Rights are the following ; which no Man, or Bodý of Men, confistently with their own Rights as Men and Citizens, or Members of Society, can for themfelves give up, or take away from others.

(3

First, "The first fundamental politive Law of all Commonwealths or States, is the establishing the Legislative Power: As the first fundamental natural Law allo, which is to govern even the Legislative Power itself, is the Prefervation of the Society."*

Secondly, The Legillative has no Right to absolute arbitrary Power over the Lives and Fortunes of the People: Nor can Mortals affume a Prerogative, not only too high for Men, but for Angels; and therefore referved for the Exercise of the Deity alone.

"The Legislative cannot justly affume to itself A Power to tule by extempore arbitrary Decrees; but it is bound to see that Justice is dispensed, and that the Rights of the Subjects be décided, by promulgated; standing and known C Laws;

Laws, and authorized independent Judges;" that is, Independent as far as possible, of Prince and People. "There should be one Rule of Justice for Rich and Poor; for the Favourité at Court, and the Countryman at the Plough."*

Thirdly, The Supreme Power cannot justly take from any Man, any Part of his Property without his Consent, 'in Person or by his Representative.

These are some of the first Principles of natural Law and Justice, and the great Barriers of all Free States, and of the British Constitution in particular. It is utterly irreconcileable to these Principles, and to many other fundamental Maxims of the common Law, common Senfe and Reafon, that a BritishHouse of Commons, should have a Right, at Pleasure, to give and grant the Property of the Colonists. That these Colonists are well entitled to all the effential Rights, Liberties and Privileges of Men and Freemen, born in Britain, is manifest, not only from the Colony Charters in general, but Acts of the British Parliament. The Statute of the 13th of Geo. 2. c.7. naturalizes even Foreigners after seven Years Residence. The Words of the Massachusetts-Charter are these, "And further our Will and Pleasure is, and we do hereby for Us, our Heirs and Succesfors, grant, establish and ordain, that all and every

every of the Subjects of Us, our Heirs and Succeffors, which shall go to and inhabit within our faid Province or Territory and every of their Children which shall happen to be born, there, or on the Seas in going thither, or returning from thence, shall have and enjoy, all Liberties and Immunities of free and natural Subjects within any of the Dominions of Us. our Heirs and Succeffors, to all Intents. Constructions and Purposes whatsoever, as if they and every of them were born within this our Realm of England." Now what Liberty can there be, where Property is taken away without Confent? Can it be faid with any Colour of Truth and Justice, that this Continent of three Thousand Miles in Length, and of a Breadth, as yet unexplored, in which however, it is fuppoled, there are five Millions of People, has the least Voice, Vote, or Influence in the Decisions of the British Parliament ? Have they, all together, any more Right or Power to return a, fingle Member to that House of Commons, who have, not inadvertently, but deliberately, assumed a Power to dispose of their Lives,* Liberties and Properties, than to chuse an Emperor of China! Had the Colonifts a Right to return Members to the British Parliament, it would only be hurtful; as from their local Situation

tnation and Circumstances, it is impossible they should be ever truly and properly represented there. The Inhabitants of this Country, in all Probability, in a few Years, will be more numerous, than those of Great Britain and Ireland together : Yet it is abfurdly expected, by the Promoters of the present Measures, that these, with their Posterity to all Generations, should be easy, while their Property shall be disposed of by a House of Commons at Three Thousand Miles distance from them ; and who cannot be supposed to have the least Care or Concern for their real Interest : Who have not only no natural Care for their Intereft, but must be in effect bribed against it ; as every Burden they lay on the Colonist is fo much. faved or gain'd to themfelves. Hitherto many of the Colonists have been free from Quit Rents; but if the Breath of a British House of Commons, can originate an Act for taking away all our Money, our Lands will go next; or be fubject to Rack Rents from haughty and rekentless Landlords who will ride at ease, while we are trodden in the Dirt. The Colonists have been branded with the odious Names of Traitors and Rebels only for complaining of their Grievances : How long fuch Treatment will, or ought to be born, is fubmitted.

A Lift of Infringements and Violations of Rights.

W E cannot help thinking, that an Enumeration of fome of the most open Infringements of our Rights, will by every candid Person be judged sufficient to justify whatever Measures have been already taken, or may be thought proper to be taken, in order to obtain a Redress of the Grievances under which we labour. Among many others, we humbly conceive, that the following will not fail to excite the Attention of all who confider themselves interested in the Happ inels and Freedom of Mankind in general, and of this Continent and Province in particular.

Ift. The British Parliament have afformed the Powers of Legislation for the Colonists in all Cafes whatfoever, without obtaining the Confent of the Inhabitants, which is ever effentially necessary to the rightful Establishment of such a Legislative.

2dly. They have exerted that assumed Power, In raising a Revenue in the Colonies without their Consent; thereby depriving them of that Right which every Man has to keep his own Earnings



Earnings in his own Hands until he shall, in Person, or by his Representative, think fit to, part with the Whole or any Portion of it. This Infringement is the more extraordinary, when we confider the laudable Care which the British Houle of Commons have taken, to referve intirely and absolutely to themselves the Powers of giving and granting Money. They, not only infift on originating every Money Bill in their own House, but will not even allow the House of Lords to make an Amendment in these Bills. So tenacious are they of this Privilege, so jealous of any Infringement of the fole and absolute Right the People have to dispose of their own Money. And what renders this infringement the more grievous is, that what of our Earnings still remains in our Hands is in a great measure deprived of it's Value, fo long as the British Parliament continue to claim and exercise this Power of taxing. us; for we cannot juftly call that our Property, which others may, when they please take away. from us against our Will.

In this refpect we are treated with lefs Decency and Regard than the Romans flewed even to the Provinces which they had conquered. They only determined upon the Sum which each flould furnish, and left every Province to raise it in the Manner most easy and convenient to themselves.

3dly. A

3dly. A Number of new Officers, unknown in the Charter of this Province, have been appointed to Iuperintend this Revenue; whereas by our Charter, the Great and General Court or Allembly of this Province, has the fole Right of appointing all Civil Officers, excepting only fuch Officers, the election and conflictution of whom is, in faid Charter, expressly excepted; among whom these Officers are not included.

4thly. These Officers are by their Commiffions invefted with Powers altogether unconstitutional, and entirely definictive to that Security which we have a right to enjoy; and to the last degree dangerous, not only to our. property, but to our lives: For the Commiffioners of his Majefty's Cuftoms in America; or any three of them, are by their Commiffion impowered, " by writing under their hands and feals to conflitute and appoint inferior Officers in all and fingular the Port within the Limits of their Commissions." Each of theft petty officers fo made is intrusted with Power more abfolute and arbitrary than ought to be, lodged in the hands of any Man or Body of Men what loever; for in the Commission aforementioned, his Majesty gives and grants unto his faid Commissioners, or any three of them. and to all and every the Collectors, Deputy-Collectors, Ministers, Servants, and all other Officers ferving & attending in all and every the Ports

Ports & other Places within the Limits of their Commillion, full Power and Authority, from time to time, at their or any of their Wills and Plealures, as well by Night as by Day, to enter and go on board any Ship, Boat, or other Vellel, riding, lying, or being within, or coming into, any Port, Harbour, Creek or Haven, within the limits of their Commillion; and allo in the day-time to go into any Houle, Shop, Cellar, or any other Place, where any Goods, Wares or Merchandizes lie concealed, or are fufpected to lie concealed, whereof the cultoms and other duties, have not been, or shall not be, duly paid and truly fatisfied, answered or paid unto the Collectors, Deputy-Collectors, Minifters, Servants, and other Officers respectively, or otherwife agreed for; and the faid Houfe, Shop, Warehoufe, Cellar, and other Place to learch and furvey, and all and every the Boxes! Trunks, Chefts and Packs then and there found to break open."

Thus our Houles, and even our Bed-Chambers, are expoled to be ranfacked, our Boxes, Trunks and Chefts broke open, ravaged and plundered, by Wretches, whom no prudent Man would venture to employ even as menial Servants, whenever they are pleafed to fay they *fufpeet* there are in the Houle, Wares, &c. for which the Duties have not been paid. Flagrant inftances of the wanton exercise of this Power, have

have frequently happened in this and other leaport Towns. By this we are cut off from that domeftic fecurity which renders the Lives of the most unhappy in some measure agreeable. These Officers may under color of Law and the cloak of a general warrant, break through the facred Rights of the Domicil, ransack Mens Houses, destroy their Securities, carry off their Property, and with little Danger to themselves commit the most horrid Murders.

And we complain of it as a further Grievance, that notwithstanding by the Charter of this Province, the Governor and the Great and General Court or Affembly of this province or Territory, for the time being, shall have full power and authority, from time to time, to make, ordain and effablish all manner of wholesome and reasonable Laws, Orders, Statutes, and Ordinances, Directions and Instructions, and that if the fame shall not within the term of three years after prefenting the fame to his Majesty in Privy Council be difallowed, they shall be and continue in full force and effect, until the fame shall be repeated by the Great and General Assembly of this province: Yet the Parliament of Great-Britain have rendered, or attempted to render, null and void, a Law of this province, made and palled in the Reign of his late Majelty George the First, intituled, . An Act stating the Fees of the Custom-House Officers

Officers within this province," and by meer dint of power, in violation of the Charter aforefaid, cftablifhed other and exorbitant Fees, for the fame Officers; any Law, of the province, to the contrary notwithftanding.

5thly. Fleets and Armies have been introduced to support these unconstitutional Officers in collecting and managing this unconstitutional Revenue; and Troops have been quartered in this Metropolis for that purpose. Introducing and quartering Standing Armies in a free Country in times of Peace, without the consent of the People either by themselves or by their Representatives, is, and always has been deemed, a violation of their Rights as Freemen; and of the Charter or Compact made between the King of Great Britain and the People of this Province, whereby all the Rights of British Subjects are confirmed to us.

6thly. The Revenue arifing from this Tax unconflitutionally laid, and committed to the management of Perfons' arbitrarily appointed and supported by an armed Force quartered in a free City, has been in part applied to the most defiructive purposes. It is absolutely neceffary in a mixt Government, like that of this Province, that a due proportion or balance of Power should be established among the several Branches' of the Legislative. Our Ancestors received

received from King William and Queen Mary a Charter, by which it was underftood by both Parties in the contract, that fuch a proportion or balance was fixed; and therefore every thing which renders any one Branch of the Legiflative more independent of the other two than it was originally defigned, is an alteration of the Conflitution as fettled by the Charter; and as it has been, until the eftablifhment of this Revenue, the conftant practice of the general Affembly to provide for the fupport of Government, fo it is an effential part of our Conflitution, as it is a neceffary means of preferving an *Equilibrium*, without which we cannot continue a free State.

In particular it has always been held, that the dependence of the Governar of this Province upon the General Affembly for his support, was necessary for the prefervation of this Equilibrium; nevertheles his Majesty has been pleased to apply Fifteen Hundred Pounds Sterling annually, out of the American Revenue, for the support of the Governor of this Province independent of the Affembly; whereby the ancient connection between him and this People is weakened, the Confidence in the Governor lessenced, the Equilibrium destroyed, and the Constitution effentially altered.

And we look upon it highly probable, from the beft intelligence we have been able to obtain, that not only our Governor and Lieutenant D 2 Governor.

Governor, but the Judges of the Superior Court of Judicature, as also the King's Attorney and Solicitor General ane to receive their Support from this grievous tribute. This will, if accomplish'd, compleat our Slavery: For if Taxes are to be railed from us by the Parliament of Great Britain without our confent, and the Men on whole opinions and decisions our Properties, Liberties, and Lives, in a great measure depend, receive their Support from the Revenues arifung from these Taxes, we cannot, when we think on the depravity of mankind, avoid looking with horror on the danger to which we are expoled ! The British Parliament have shewn their wildom in making the Judges there as independent as possible both on the Prince and People, both for place and fupport : But our Judges hold their commissions only during pleasure ; the granting them Salaries out of this Revenue is fendering them dependent on the Crown for their fupport. The King, upon his first accelfion to the Throne, for giving the last Hand to the independency of the Judges in England, not only upon himfelf but his fuccessors, by recommending and confenting to an Act of Parliament, by which the Judges are continued in office, norwithstanding the demile of the King, which vacates all other Commission, was applauded by the whole Nation. How alarming therefore must it be to the inhabitants of this province, to find fo wide a difference made between

between the lubjects in Britain and America, as the rendering the Judges here altogether dependent on the Grown for their support.

7thly. We find outfelves greatly oppressed by Instructions sent to out Governor from the Court of GreatBritain; whereby the first branch of our legislature is made meerly a ministerial Engine. And the Province has already felt such effects from these instructions, as we think, justly intitle us to fay, that they threaten an entire destruction of our Liberties; and must soon, if not check'd, render every branch of our government a useles burthen upon the people. We shall point out some of the alarming effects of these instructions which, have already taken place.

In confequence of instructions, the Governor has called and adjourned our General Assemblies to a place highly inconvenient to the Members and greatly difadvantageous to the interest of the province, even against his own declared intention.

In confequence of inftructions, the Affembly has been prorogued from time to time, when the important concerns of the Province required their meeting.

In obedience to instructions the General Assembly was Anno 1768 dissolved by Governor Bernard, because they would not consent to refcind the Resolution of a former House, and thereby facrifice the Rights of their Constituents.

By an Instruction, the honorable his Majesty's Council are forbid to meet and transact matters of publick concern as a council of advice to the Governor, unless called by the Governor; and if they should from a zealous regard to the Interest of the province fo meet at any time, the Governor is ordered to negative them at the next Election of Councellors. And although by the Charter of this province the Great and General Court have full power and authority to impole Taxes upon the Estates and perfons of all and every the proprietors and inhabitants of this province, yet the Governor has been forbidden to give his confent to an act impoling a Tax for . the necessary support of government, unless such persons as were pointed out in the faid instruction, were exempted from paying their just proportion of faid Tax.

His Excellency has also pleaded inftructions for giving up the provincial Fortress, Castle William, into the hands of Troops, over whom he had declared he had no controul (and that at a time when they were menacing the flaughter of the inhabitants of the town, and our itreets were stain'd with the blood which they had barbarously shed.) Thus our Governor, appointed and paid from Great-Britain with Money forced from us, is made an inftrument of totally preventing, or at least of rendering futlle, every attempt of the other two

two branches of our Legislative in favour of a diffressed and wronged people : And left the complaints naturally occasioned by such oppression should excite compassion in the royal Breast, and induce his Majesty seriously to set about relieving us from the cruel Bondage and Insults which we, his loyal Subjects, have so long suffered, the Governor is forbidden to consent to the payment of an Agent to represent our grievances at the Court of Great Britain, unless he, the Governor, consent to his Election; and we very well know what the Man must be to whole appointment a Governor, in fuch circumstances, will consent.

While we are mentioning the Infringements of the Rights of this Colony in particular by means of Infructions, we cannot help calling to remembrance the late unexampled Supenfion of the Legiflative of a Sifter Colony, New-York, by force of an Infruction, until they should comply with an arbitrary act of the British Parliament, for quartering Troops, designed, by military execution, to enforce the taising of a tribute.

8thly. The extending the power of the Courts of Vice-Admiralty to fo enormous a degree, as deprives the people in the colonies, in a great measure, of their incltimable right to trials by Jurist; Faries; which has ever been juilly confidered as the grand Bulwark and Security of English property.

This alone is fufficient to roule our jealoufy: And we are again obliged to take notice of the remarkable contrast, which the British parliament have been pleased to exhibit between the Subjects in Great-Britain and the Colonies. In the fame Statute, by which they give up to the decilion of one dependent interested Judge of Admiralty the effates and properties of the Colonilits, they expreisly guard the eftates and properties of the People of Great-Britain ; For all forfeitures and penalties inflicted by the flatute of the fourth of George the third, or any other Act of Parliament relative to the Trade of the Colonies, may be fued for in any Court of Admiralty in the Colonies; but all penalties and forfeitures which shall be incurred. in Great-Britain, may be fued for in any of his Majesty's Courts of Record in Westminster, or in the Court of Exchequer in Scotland, re-Thus our Birthrights are taken fpectively. from us; and that too with every mark of indignity, infult and contempt. We may be harralled and dragged from one part of the Continent to the other (which some of our Brethren here and in the country towns already have been) and finally be deprived of our whole property, by the arbitrary determination of one biaffed; capticious Judge of the Admiralty.

othly:

othly. The reftraining us from creeting Slitting-Mills for manufacturing out from the natural produce of this Country, is an Infringement of that Right with which God and Nature have invested us, to make use of our skill and industry in procuring the necessaries and conveniencies of Life. And we look upon the Restraint laid upon the Manufacture and Transportation of Hats to be altogether unreasonable and grievous. Although by the Charter all Havens, Rivers, Ports, Waters, &c. are exprefsly granted the Inhabitants of the Province and their Succeffors, to their only proper ula and behoof forever, yet the British Parliament passed an act, whereby they restrain us from carrying our Wool, the produce of our own Farms, even over a Ferry; whereby the Inhabitants have often been put to the expence of carrying a Bag of Wool near an hundred miles by land, when passing over a River or Water of one quarter of a mile, of which the province are the absolute proprietors, would have prevented all that trouble.

10thly. The Act paffed in the last Seffion of the British Parliament, intituled, An Act for the better preserving his Majesty's Dock-Yards, Magazines, Ships, Ammunition and Stores, is, as we apprehend, a violent Infringemen of our Rights. By this Act, any one of us may be taken from hisFamily, and carried to E any

any part of Great-Britain, there to be tried, whenever it shall be pretended that he has been concerned in burning or otherwife destroying any Boat or Vessel, or any Materials for building, &c. any naval or victualling Store, &c. belonging to his Majesty. For by this Act all Perfons in the Realm, or in any of the Places thereto belonging (under which Denomination we know the Colonies are meant to be included) may be indicted or tried either in any County or Shire within this Realm. in like manner and form as if the Offence had been committed in faid County, as his Majesty and his Succeffors may deem most expedient. Thus we are not only deprived of our grand Right to Trial by our Peers in the Vicinity, but any person suspected, or pretended to be suspected, may be hurried to Great-Britain, to take his Trial in any County the King or his Succeffors shall please to direct; where, innocent or guilty, he is in great danger of being condemned ; and whether condemned or acquitted, he will probably be ruined by the Expence attending the Trial, and his long Absence from his Family and Business; and we have the ftrongest reason to apprehend that we shall soon experience the fatal Effects of this Act, as about the Year 1769, the British Parliament passed Refolves for taking up a number of perfons in the Colonies and carrying them to Great-Britain for trial, pretending that

that they were authorised so to do, by a Statute passed in the Reign of Henry the Eighth, in which they fay the Colonies were included, although the Act was passed long before any Colonies were settled, or even in contemplation.

11thly. As our Ancestors came over to this Country that they might not only enjoy their civil but their religious Rights, and particularly defired to be freed from the Prelates, who in those times cruelly perfecuted all who differed in sentiment from the established Church ; we cannot fee without concern, the various attempts which have been made, and are now making, to establish an American Episcopate. Our Episcopal brethren of the Colonies do enjoy, and rightfully ought ever to enjoy, the free exercise of their Religion; but as an American Episcopate is by no means effential to that free exercise of their Religion, we cannot help fearing that they who are fo warmly contending for fuch an Establishment, have Views altogether inconfiftent with the universal and peaceful enjoyment of our Christian privileges ; And doing or attempting to do any thing which has even the remotelt tendency to endanger this Enjoyment, is justly looked upon a great Grievance, and allo an Infringement of our Rights; which is not barely to exercife, but peaceably and fecurely to enjoy, that Liberty with which CHRIST hath made us free.

And
And we are further of Opinion, that no Power onEarth can juftly give either temporal or fpiritual Juri/diction within thisProvince, except the Great & General Court. We think therefore that every defign for establishing the Jurifdiction of a Bishop in this Province, is a defign both against our civil and religious Rights : And we are well informed, that the more candid & judicious of our Brethren of the Church of England in this and the other Colonies, both Clergy and Laity, conceive of the establishing an American Episcopate both unnecessary and unreasonable.

12thly. Another Grievance under which we labour is, The frequent Alteration of the Bounds of the Colonies by Decifions before the King and Council, explanatory of former Grants and Charters. This not only fubjects Men to live under a Conffitution to which they have not confented, which in itfelf is a great Grievance ; but moreover under Color, that the Right of Soil is affected by fuch Declarations, some Governors, or Ministers, or both in Conjunction, have pretended to grant in Consequence of a Mandamus many Thousands of Acres of vacant and appropriated Lands near a Century past, and rendered valuable by the Labors of the prefent Cultivators and their Ancestors. There are very notable Instances of Settlers, who having first purchased the

the Soil of the Natives, have at confiderable Expence obtained Confirmations of Title from. this Province; and, on being transfer'd to the Iurifdiction of the Province of New-Hamp (hire, have been put to the Trouble and Cost of a new Grant or Confirmation from thence: and after all this, there has been a third Declaration of the Royal Will, that they shou'd thenceforth be confidered as pertaining to the Province of New-York. The Troubles, Expences and Dangers which Hundreds have been put to on fuch Occasions, cannot here be recited : but so much may be faid, that they have been most cruelly harrassed, and even threatened with . a military Force, to dragoon them into a Compliance with the most unreasonable Demands.

A LETTER of Correspondence, to the other Towns.

BOSTON, November 20, 1772.

Gentlemen,

7E, the Freeholders and other Inhabitants of Boston, in Town-Meeting duly affembled, according to Law, apprehending there is abundant Reason to be alarmed that the Plan of Despotism, which the Enemies of our invaluable Rights have concerted, is rapidly hastening to a completion, can no longer conceal our impatience under a constant, unremitted, uniform Aim to inflave us, or confide in an Administration which threatens us with certain and inevitable destruction. But, when in Addition to the repeated Inroads made upon the Rights and Liberties of the Colonists, and of those in this Province in particular, we reflect on the late extraordinary Measure in affixing Stipends, or Salaries from the Crown to the Offices of the Judges

Judges of the Superior Court of Judicature, making them not only intirely independent of the People, whole Lives and Fortunes are fo much in their Power, but absolutely dependent on the Crown, (which may hereafter be worn by a Tyrant) both for their Appointment and Support, we cannot but be extremely alarm'd at the mischievous Tendency of this Innovation; which, in our Opinion is directly contrary to the Spirit of the British Constitution, pregnant with innumerableEvils,& hath a directTendency to deprive us of every thing valuable asMen, as Christians, and as Subjects, entitled, by the Royal Charter, to all the Rights, Liberties and Privileges of native Britons. Such being the critical State of this Province, we think it our Duty on this truly diffreffing Occasion, to afk you, What can withstand the Attacks of mere Power? What can preferve the Liberties of the Subject, when the Barriers of the Constitution are taken away ! The Town of Boston, confulting on the Matter abovementioned, thought proper to make Application to the Governor by a Committee ; requesting his Excellency to communicate fuch Intelligence as he might have received, relative to the Report of the Judges having their Support independent of the Grants of this Province, a Copy of which you have herewith in Paper No. 1.* To which we received as Answer the Paper No. 2. ‡ The Town

Town on further Deliberation, thought it adviscable to refer the Matter to the Great and Ceneral Affembly ; and accordingly in a fecond Address as No. 3. + they requested his Excellency that the General Court might convene at the Time to which they then flood proregued ; to which the Town received the Reply as inNo. 4. § in which we are acquainted with his Intentions further to prorogue the General Affembly, which has fince taken Place. Thus, Gentlemen, it is evident his Excellency declines giving the least Satisfaction as to the Matter, in Request. : The Affair being of public Concernment, the Town of Befon thought it necessary to confult with their Brethren throughout the Province ; and for this Purpole appointed a Committee, to communicate with our Fellow Sufferers, respecting this recent Instance of Oppression, as well as the many other Violations of our Rights under which we have groaned for several Years past-This Committee have briefly recapitulated the lenfe we have of our invaluable Rights, as Men, as Christians, and, as Subjects ; and wherein we conceive those - Rights to have been violated, which we are defirous may be laid before your Town, that the Subject may be weighed as its Importance requires, and the collected wildom of the whole People, as far as possible, be obtained, on a deliberation of fuch great and lasting moment

ment as to Involve in it the Fate of all our Po-Aerity.-Great Pains has been taken to perfwade the British Administration to think, that the good People of this Province in general are quiet and undisturbed at the late Measures : and that any Uncafiners that appears, arifes only from a few factious defigning and difaffected Men. - This renders it the more necelfary, that the fenfe of the People fould be explicitly declared.----A' free Communication of your 'Sentiments' to this Town, of our common Danger, is earneftly folicited and will be gratefully received. If you concur with us in Opinion, that our Rights are properly flated, and that the leveral Acts of Parliament, and Measures of Administration, pointed out by us, are subversive of these Rights, you will doubtlefs think it of the utmost importance that we fland firm as one Man, to recover and support them ; and to take fuch Measures, by directing our Representatives, or otherwise, as your Wifdom and Fortitude shall dictate, to rescue from impending Ruin out happy and gloricus Constitution. But if it should be the general Voice of this Province, that the Rights, as we have stated them, do not belong to us; or, that the feveral Measures of Administration in the British Court, are no Violations of these Rights ; or, that if they are thus violated or infringed, they are not worth contending for, or refolutely mantaining ; -------fhould this be the general Voice

Voice of the Province, we must be refigned to our wretched Fate ; but shall forever lament the Extinction of that generous Ardor for Civil and Religious Liberty, which in the Face of every Danger, and even Death itself, induced our Fathers, to forfake the Bofom of their Native Country, and begin a Settlement on bare Creation.-But we trust this cannot be the Cafe : We are fure your Wifdom, your Regard to Yourfelves and the rifing Generation, cannot fuffer you to doze, or let fupinely indifferent, on the brink of Destruction, while the Iron Hand of Oppression is daily tearing the the choicest Fruit from the fair Tree of Liberty, planted by our worthy Predeceffors, at the Expence of their Treasure, and abundantly water'd with their Blood.-It is an observation of an eminent Patriot, that a People long inuted to Hardships, loose by Degrees the very notions of Liberty; they look upon themfelves, as Creatures at Mercy, and that all Impolitions laid on, by Superior Hands, are legal and obligatory.-But thank Heaven this is not yet verified in America ! We have yet some Share of public Virtue remaining : We are not afraid of Poverty, but difdain Slavery.-The Fate of Nations is fo precarious, and Revolutions in States fo often take Place at an unexpected Moment, when the Hand of Power, by Fraud or Flattery, has fecured every Avenue of Retreat, and the Minds of the Subject

ject debaled to its Purpole, that it becomes every Well-Wisher to his Country, while it has any Remains of Freedom, to keep an Eagle Eye upon every Inovation and Stretch of Power, in those that have the Rule over us. A recent Instance of this we have in the late Revolutions in Sweden ; by which the Prince, once fubject to the Laws of the State, has been able of a fudden, to declare himself an absolute Monarch. The Sweeds were once a free, martial and valiant People : Their Minds are now fo debased, that they even rejoice at being fubject, to, the Caprice and arbitrary Power of a Tyrant, and kils their Chains. It makes us shudder to think, the late Measures of Administration may be productive of the like Catastophe ; which Heaven forbid !----Let us confider Brethren, we are strugling for our best Birth Rights and Inheritance ; which being infringed, renders all our Bleffings precarious in their Enjoyments, and confequently trifling in their Value. Let us disappoint the Men, who are raising themselves on the Ruin of this Country. Let us convince every Invader of our Freedom, that we will be as free as the Constitution our Fathers recognized, will justify.

The foregoing Report was twice read diffinitly, and amended in the Meeting. And then the Queffion was put, Whether the fame be accepted ? And pajjed in the Affirmative, Nem. Con.

THE Freeholders and other Inhabitants of the Town of Bofton, legally affembled in Faneuil-Hall, beg Leave to acquaint your Excellency, that a Report has prevailed, which they have reason to apprehend is well groundsed, that Stipends are affixed to the Offices of the Judges of the Superior Court of Judicature, &c. of this Province, whereby they are become Independent of the Grants of the General Affembly for their Support; contrary to ancient and invariable Ufage. This Report has fpread an Alarm among all confiderate perfons who have heard of it in Town and Country ; being viewed, as tending rapidly to compleat the System of their Slavery; which originated in the House of Commons of Great-Britain, affuming a Power and Authority, to give and grant the Monics of the Colonists without their Consent, and against their repeated Remonstrances. And, as the Judges hold their Places



Places during Pleafure, this Establishment appears big with fatal Evils, so obvious that it is needless to trespass on your Excellency's Time in mentioning them.

It is therefore the humble and earnest Request of the Town, that your Excellency would be pleased to inform them, Whether you have received any such Advice, relating to a Matter so deeply interesting to the Inhabitants of this Province, which gives you Assurance that such an Establishment has been, or is likely, to be made.

THAT your Petitioners are fill greatly alarmed at the Report which has been prevalent of late, viz. That Stipends are affixed to the Offices of the Judges of the Superior Court of Judicature of this Brovince, by Order of the Crown, for their Support.

Such an Establishment is contrary, not only to the plain and obvious Sense of the Charter of this Province, but also to some of the fundamental

damental Principles of the Common Law; to the Benefit of which, all British Subjects, whereeven dispersed throughout the British Empire, are indubitably intitled.

Such a Jealoufy have the Subjects of England for their Rights, Liberties and Privileges. and fo tender a Regard has been shown to them by his Majefty, that notwithstanding the Provision made at the Revolution, that the Judges of the King's Superior Courts of Law there, should hold their Commissions, not at Pleasure, but during good Behaviour, and fince that Time for their Support, His Majesty, among other the first Acts of his Reign, was graciously pleased to recommend it to Parliament, and an A& passed, that their Commissions should not cease at the Demise of the King; whereby every thing poffible in human Wildom feems to have been done, to establish an Impartiality in their Decifions, not only between Subject and Subject, but between the Crown and the Subject.—Of how much greater Importance must it be to preferve from the least supposeable Bias, the Judges of a Court, invested by the Laws of this Province, which have been approved of by Majesty, with Powers as fully and amply to all Intents and Purposes whatfoever, as the Courts of King's-Bench, Common Pleas and Exchequer, within his Majefty's Kingdom of England have, or ought to have?

Your

Your Excellency will allow your Petitioners, with due Submiffion to repeat, that this Eftablifhment appears to them pregnant with fuch fatal Evils, as that the most diffant thought of its taking Effect, fills their Minds with Dread and Horror.

These Sir, are the Sentiments and Apprehensions of this Metropolis: Expressed however, with due Defference to the Sentiments of the Province, with which your Petitioners are anxiously follicitous of being made acquainted.

It is therefore their earness and humble Request, that your Excellency would be pleased to allow the General Assembly to meet at the Time to which it now stands prorogued; in order, that in that *Constitutional* Body, with whom it is to inquire into Grievances and Redress them, the joint Wisdom of the Province may be employed, in deliberating and determining on a Matter so important and alarming.

The GOVERNOR'S ANSWER to the foregoing PETITION.

GENTLEMÉN,

THE Royal Charter referves to the Governor full Power and Authority, from time to time, as he fhall judge necessary, to adjourn, proposue and differve the General Affembly.

In the Exencise of this Rower, both as to Time and Place, I have always been governed by a Regard to his Majesty's Service and to the Interest of the Province.

It did not appear to me necessary for those Purposes that the Assembly should meet at the Time to which it now shands prorogued, and, before I was informed of your Address, I had determined to prorogue it to a further Time.

The Reasons which you have advanced have not altered my Opinion.

If, notwithstanding, in Compliance with your Petition, I should alter my Determination and meet the Assembly, contrary to my own Judgment, at fuch Time as you judge necessary, I should, in Effect, yield to you the Exercise of that Part of the Prerogative, and should be unable to justify my Conduct to the King. There There would, moreover, be danger of encouraging the Inhabitants of the other Towns in the Province to allemble, from time to time, in order to confider of the Necessity or Expediency of a Selfion of the General Allembly, or to debate and transact other Matters which the Law that authorizes Towns to allemble does not make the Business of a Town-Meeting.
